

### **OPPI Municipal Survey Results**

#### Thank You to Members Who Filled Out OPPI's Municipal Survey



OPPI would like to share the results of our municipal survey that ran at the end of April. As members recall, many of the questions OPPI received focused on municipal processes, but we also want to learn about the practices related to these processes and how they may have changed because of COVID-19. Here is a high-level overview of the results:

- Over 60% of municipal planning departments have been declared an "essential service"
- Some special procedures have been put in place to manage applications, this includes accepting electronic submissions and payments, virtual meetings with proponents, notices published online, and much more
- Only 21% of municipalities have an "e-permitting" system to accept applications
- Technologies such as Zoom, Microsoft Teams, WebEx and others are being used as a solution for internal and external meetings
- 86% of respondents think more provincial guidelines on virtual public engagement will

Is our vision clear to others? How we see and respond to landscape, what we envision through design, affects the quality, value and associated experience of places. There is always room for improvement; that much is clear.



#### Legislative Corner Updates



Ontario's Environmental Registry website has posted an <u>important notice</u> temporarily exempting ministries from the minimum 30-day consultation requirements to post proposals for acts, regulations, policies and instruments to the Environmental Registry. OPPI will continue to monitor the registry website and provide items open for comment, when available.

We know members are busy working through other priorities, but for those who can provide comments the following regulatory items are open for public comment (deadlines in brackets):

- Proposed agricultural land use amendment for Hearst and Kapuskasing (May 15, 2020)
- Proposed amendments to Ontario Regulation 244/97 and the Aggregate Resources of Ontario Provincial Standards under the Aggregate Resources Act (May 15, 2020)
- New Statement of Environmental Values for Ministry of Infrastructure (May 25, 2020)
- Proposal to identify and protect a corridor of land for future electricity infrastructure in the Greater Toronto Area (June 8, 2020)

# Ombudsman Ontario Report on the Township of Russell April 2nd Special Meeting By Electronic Participation



The Ombudsman received a complaint about a special meeting held by the Township of Russell on April 2 by electronic participation due to COVID-19. The complaint alleged that the meeting agenda did not provide a link to the website where the meeting would be broadcast. The Ombudsman found that council for the Township did not

violate the open meeting rules. The Township provided notice to the public that the meeting would be held via electronic participation and posted a link to the broadcast on its website and on social media prior to holding the meeting.

The Ombudsman commended the Township of Russell for taking additional steps to ensure that information about how to observe and participate in electronic meetings was widely available to the public. The Ombudsman urged all municipalities to do as much as possible to facilitate access by the public to any meetings held electronically during a declaration of emergency. This was the first time the Ombudsman conducted an investigation into a municipal meeting following the passage of the *Municipal Emergency Act, 2020*, which allows for additional flexibility in holding electronic meetings during an emergency, such as the COVID-19 pandemic.
