

Legislative Corner Updates



Amendment #1 to the Growth Plan Has Come Into Effect



On August 28, 2020, Amendment #1 to A Place to Grow: Growth Plan for the Greater Golden Horseshoe was brought into effect. This follows a 45-day consultation period which was open from June 16 to July 31, 2020. The amendment includes changes to the Growth Plan's population and employment forecasts, extends the horizon year for planning, and includes other policy changes which

aim to increase housing supply, attract business investment, and better align growth with infrastructure. Members can refer to the entry on the <u>Environmental Registry of Ontario website</u> for a summary of the amendment.

Regulations Open for Comment

Ontario's Environmental Registry website has posted an <u>important notice</u> temporarily exempting ministries from the minimum 30-day consultation requirements to post proposals for acts, regulations, policies and instruments to the Environmental Registry. OPPI will continue to monitor the registry website and provide items open for comment, when available.

We know members are busy working through other priorities, but for those who can provide comments the following regulatory items are open for public comment (deadlines in brackets):

- Proposed changes to environmental approvals for municipal sewage collection works (September 6, 2020)
- Proposal to extend the current moratorium on water bottling permits (September 27, 2020)
- Proposed regulation amendment to establish a second local forest management corporation for the Temagemi Crown Forest Management Unit under the Ontario Forest Tenure Modernization Act, 2011 (October 5, 2020)
- Proposed amendments to the Director's Technical Rules made under section 107 of the Clean Water Act, 2006 (November 9, 2020)

Beyond Blame: Leadership, Collaboration and Compassion in the Time of COVID-19



OPPI would like to thank George McKibbon for sharing an article he co-wrote with John Forester for Socio-Ecological Practice Research to share with members.

As the COVID-19 pandemic confronts us with our interdependence and vulnerability, we can respond in distinctly different ways. Our fears may prompt blame and

its rationalization, but our fears may also motivate inquiry and learning. Compassion and collaboration hang in the balance—shaped in part, we shall argue, by political leadership, scientific expertise, and emergent social solidarity. Blaming others may side-step responsibility, but it will not encourage or target actions in response to suffering. But admitting ignorance and the need to learn, supporting widespread testing, and following best available public health advice might cultivate broader public action and confidence—as evidenced both in exemplary public leadership and in shared actions of mutual aid like social distancing.

We argue that public leadership can model and encourage—or discourage!—compassionate and collaborative action, and we examine a striking natural experiment: the parallel COVID-19 briefings of the public by President Trump's White House Task Force and New York State's Governor Andrew Cuomo. Although many of our arguments may have widespread applicability, this essay's principal perspective is primarily based upon our experiences in North America, and it is therefore American-centric to a large extent.

OPPI Council is meeting for two days - September 14 and 15th. The first day will see Council and OPPI staff participating in a day-long Indigenous cultural virtual training session, rescheduled from March of this year, as part of addressing one of the <u>recommendations</u> in the <u>Indigenous Planning Perspectives Task Force Report</u>.

On September 15, OPPI Council will meet to discuss a number of strategic issues. Council will receive an update on OPPI's Resiliency Plan that is being used to guide the Institute over the next 18-24 months. Council will also receive an update on OPPI20 and will discuss their responsibilities ahead of the upcoming conference. OPPI's 2021 Financial Plan will be presented at this meeting for Council to approve.

OPPI Council meets several times a year. Council approved agendas and minutes are

available upon request to the <u>OPPI office</u>. The goal is to engage members in shaping the direction and initiatives of OPPI and continue to deliver on our INSPIRE OPPI Strategic Plan 2020. Members are encouraged to speak up and get involved and stay in touch throughout the year through OPPI's many communications channels.
